7. BDS SECTION MATTERS

7(22) KGF College of Dental Sciences & Hospital, KGF

To consider the Joint Inspection report of the Council's Inspectors Dr. Omkar Shetty, Navi Mumbai and Dr. Anil, Mahe to inspect and report on (i) Standard and actual Physical facilities made available for teaching BDS Course, (ii) the compliance of norms prescribed by the Council with regard to the teaching load, admission strength etc. by the institution and (iii) the general overall impression about the institution. The Hon'ble High Court of Karnataka at Bengaluru vide its Order dated 24.02.2016 in W.P. No. 27754 of 2015, inter-alia, decided to hold a spot inspection and satisfy themselves as to whether the petitioner-institution has complied with all the requirements.

Chemical Laboratory:- Burnout furnace – 1, Porcelain furnace – 1, Sandblasting Machine – 1, Lab Airrotor – 1, Pindex System – 1, Circular Saw – 1, Vacuum Mixer – 1, Pneumatic Chisel – 1.
Oral Medicine & Radiology:- Intra Oral X-ray unit – 1, Lead Gloves – 1.
