7(4) Index Institute of Dental Sciences, Indore

To consider the Joint Inspection Report of the Council's Inspectors Dr. Mridula Trehan, Jaipur and Dr. Divya Kalra, Rohtak (carried out on 28th & 29th November, 2017) to verify the achievement of the annual target for renewal of the Central Government permission for admitting 4th batch of students in BDS Course under Malwanchal University, Indore with 100 seats at Index Institute of Dental Sciences, Indore for the academic session 2018-2019.

Compliance

1. In the Department of Orthodontics, the students do not make any removable appliances for the patients.
2. In the Central Library, there are no national or international journals for the year 2017.
3. Dr. Rolly S. Agarwal (Prof. in Conservative) does not have the relieving order of previous appointment.
4. Dr. Pankaj Kumar (Asst. Prof. in Gen. Medicine) does not have the appointment order of previous appointment.
5. Dr. Vineet Gohiya (Professor & Head in Dept. of Anatomy) does not have appointment order of previous appointment.
6. Dr. Anjali Prasad (Associate Professor) in Dept. of Anatomy does not have appointment order of previous appointment.
7. Dr. Suraj Tripathi (Professor in Dept. of Pharmacology) does not have appointment order of previous appointment.

To consider the Joint Inspection Report of the Council's Inspectors Dr. Sunil Sharma, Jaipur and Dr. Atul Bhatnagar, Varanasi (carried out on 8th & 9th December, 2017) to verify the achievement of the annual target for renewal of the Central Government permission for admitted 5th batch of students in BDS Course with 100 seats at D.Y. Patil Dental School, Pune for the academic session 2018-2019.

Compliance

1. **Man Power Requirement:** The Inspectors could not verify the following Man Power Requirement & other facilities in attached General Hospital as they were denied access by hospital authorities:
Medical Staff: General Surgery-2, General Medicine-2, Obstetrics & Gynaecology-2, ENT-2, Paediatrics-2, Anaesthesia-2, Orthopedics-2, Pharmacologist-1, Radiologist-1, GDMO-1, Community Medicine-1, Hospital Administration-1
Nursing Staff: Matron-1, Sister Incharge-6, O.T. Nurses-6, General Nurses-20, Labour Room Nurses-4
Health Staff: Female Health Assistant-1, Extension Educator Paramedical Staff-1, Lab Technician/Blood Bank Tech-4, ECG Technician-1, Pharmacist-4, Sr. Radiographer-1, CSSD-2, Medical Records-1
Engineering Staff: Civil-2, Mechanical-2, Electrical-2, Engineering Aid-4

2. University affiliation for session 2018-19 is not available.
3. All the wards and ICU facilities were locked & only few patients were seen in Hospital OPD.
4. The details of last 6 months occupancy and OPD details were not provided by authorities.
5. The OPD and IPD details on the day of Inspection were not provided by the authorities of the hospital and Dental College.
6. The teaching of BDS III yr students in the subjects of Medicine & Surgery is compromised. (especially clinical & ward teaching)
7. The agreement between D.Y. Patil Dental School, Pune Municipal Corporation, regarding hospital attachment is doubtful, as final permission letter has not been issued by Municipal Corporation.
8. Few patients were seen in various dental clinical departments. It seems that Major & Minor O.T. are never been used in department of Oral & Maxillofacial Surgery. (No records of major & minor surgeries)
9. In department of Prosthodontics and Crown & Bridge the space is not sufficient to accommodate the 34 dental chairs.
10. The Phantom Lab in department of Conservative Dentistry & Endodontics is not functional.
11. Radiation Safety in department of Conservative Dentistry & Pedodontics is compromised.
12. Dental Mobile Van is not equipped as per DCI requirements.
13. Photocopy area is not available in the library.
14. The following Dental Teaching Staff were could not produce their residence proof as per DCI guidelines:
 - (i) Dr. Shrikant Sonune, Assistant Professor in department of Oral Pathology & Microbiology
 - (ii) Dr. Karibasappa G.N., Professor in department of Public Health Dentistry
15. Audited financial report for the year 2017 is not available.
16. Segregation of Bio-Waste at department level is compromised.
17. There are deficiencies of **Non - Teaching Staff / Ministerial Staff** i.e. Assistants-3, Receptionist-9, D.S.A. (Chair side Attendant)-20, Dent. Hygst.-3, Radiographer-1, Electricians-2, Plumber-1, Mason-1, Attenders-13, Nurses-4.

18. There are following deficiencies of Major Equipments in various departments:
- Prosthodontics and Crown & Bridge:** Extra Oral/Intra Oral tracer-2, Needle burner with syringe cutter-1
- Ceramic and Cast Partial Laboratory:** Composite curing unit-1
- Conservative Dentistry and Endodontics:** Pulp Tester-Digital-3, Automatic Developer-1 (no lead apron and no lead gloves), Phantom lab Unit- Available but non functional
- Oral & Maxillofacial Surgery:** Needle burner with syringe cutter-2, Extraction forceps sets-4, Dental elevators-3, Oxygen cylinder with mask-1 (available but no oxygen)
- Minor Surgery:** Dental Chairs and Units-5 (available but non functional)
- Periodontology:** Dental Chairs and Units-Available but no air polisher, Electro surgical cautery-available but non functional
- Orthodontics:** Unit mount scaler-2, Typodont- available but non metallic, Typhodont articulator-4
- Paediatric and Preventive Dentistry:** Extraction forceps-4, Intra Oral X-ray – available but no lead apron
- Pedo Lab:** Lab micro motor-3
- Public Health Dentistry:** Ultrasonic cleaner-1, Needle burner with syringe cutter-1
- Mobile Clinic:** Mobile Dental Van- Dental Chair-1, Autoclaves-1, Glass bead sterilizers-1, Metal cabinet-1, Portable dental chair-2, Stabilizer-1, Generator-1, Water tank-1, Oxygen cylinder-1, Public address system-1, TV and video cassette player-1
- Infrastructure & Functional Requirement:** Auditorium – available but with seating capacity of 250 peoples
