### **OBSERVATIONS**

As mentioned in the inspection proforma, there were 23 faculties in basic medical subjects, but the attendance sheet provided by the Institution mentioned only 13 faculties. On the day of inspection i.e. on 3<sup>rd</sup> August, 2017, only 06 (six) faculties reported to the department after 11.30 Hrs., and on 4<sup>th</sup> August, 2017 13 faculties were present. In spite of repeated requests, no Affidavits was submitted to the Inspectors till 5 O 'Clock by the college authorities.

- (i) Further, in the subject of Human Anatomy, the faculties were from ENT and General Surgery speciality.
- (ii) In Physiology, the Prof. & HOD has already crossed the age limit of 65 years.
- (iii) No faculties in the department of Pharmacology, General Pathology & Microbiology and Anesthesia were present on 3<sup>rd</sup> August, 2017.
- (iv) Interestingly, the circular issued on 15.05.2017 indicated the commencement of vacation of all the medical faculties from 17.05.2017 till further orders. However, the

attendance during 3<sup>rd</sup> & 4<sup>th</sup> indicates all the faculties are part-time in nature.

- (v) The random check of practical notebooks and attendance showed inadequate maintenance and absence of students during theory & practical classes.
- (vi) The civil hospital attached to Gandhinagar has not imparted any practical training during clinical posting of the 3<sup>rd</sup> year BDS students in the subject of General Medicine and General Surgery and no records are available in the hospital and the students could not provide any case history sheet.

- The application form of Dr. Rahul Dhanak, OMFS; Dr. Dharampal Hada, Orthodontics; Dr. Bhavik Thakkar, Orthodontics; Dr. Deepa Singhal, Pedodontics; Dr. Neelam P. Parikh, Oral Pathology; Dr. Nilesh Raval, Oral Medicine & Radiology submitted by the Principal on 3<sup>rd</sup> August appears to be fabricated since on 4<sup>th</sup> August both Dr. Hada and Dr. Thakkar has given in writing that they are not attending the college since last 3 months and only have joined on 4<sup>th</sup> August for the inspection purpose (the copy of the applications are enclosed herewith).

The community dental van was absent on 3<sup>rd</sup> citing the reason that the van was in garage for repairing, but was present on 4<sup>th</sup> August during inspection. There are only two dental chairs in a very shady condition with no accessories like Audiovisual, airoter, micromotor and appears to be non-functional for many days.

The time-table for lectures were not followed as observed on 3<sup>rd</sup>, the schedule for 3<sup>rd</sup> year BDS students were to attend the surgery and medicine clinics, but it was physically found that there was starting of medicine lecture at 10 AM.

Dr. Bankim Mistry, Professor, Prosthodontics does not fulfil the criteria in respect of Publications.

**Infrastructure (Lecture Theatres):**

As per DCI guideline, the minimum requirement for 100 BDS admissions is four lecture theatres. But the said dental college has no lecture theatres of its own and is shared with the adjacent Institute of Business School of the University having two lecture theatres only.

**Library:**

The library has not five copies of each book as per DCI norm for 100 admissions.  
The journal room and photocopying area was not available.

**Oral Surgery:**

- There is no minor OT in the department.
- Front loading autoclave only one instead of two as per requirement.
- Ultrasonic cleaner not present.

**Oral pathology:**

- Only one dental chair in the department.
- Since there is no PG admission for last three years the PG areas are not existing.
- Logbooks of the 1<sup>st</sup> & 3<sup>rd</sup> year BDS students are not updated.

**Pedodontia:**

- No separate lab for PG.
- Pre-clinical area for PG and UG are at separate place outside the department and shared with conservative and don't have phantom heads.
- Typodont with permanent teeth are not present.
- No double disc model trimmers in the lab.
- No pressure moulding machine.
- No acrylizer.

**Orthodontics:**

- Two Dental chairs with unit are less than required in the UG section.
- One autoclave (front loading) deficient.
- Unit mount scaler not present in the UG section.

**Periodontics:**

- UG section is not in one area, rather two separate rooms with 18 & 16 dental chairs respectively on the same floor.
- Electro-polisher in UG section not present.
- Only one front loading autoclave that too non-functional.
