Sub: Curbing the menace of ragging in Educational Institutions - Implementation of directions of Hon'ble Supreme Court of India and DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009. - Reg.

Dental College & Hospital, Aurangabad in response to DCI letter No.DE-167-2016/1824 dated 20.05.2016 therein a last and final opportunity was given to 28 Dental Colleges to furnish the requisite information/feedback, within 15 days in compliance to above DCI Regulations, however, 03 Dental Institutions have not yet furnished the requisite information/feedback. The Executive Committee after discussion and deliberations decided as under:-

Since the following dental colleges have not yet furnished the requisite information as per annexure-II of section 12 of DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, even after repeated requests, the Executive Committee decided that necessary action as per section 11.4 of above regulation may be initiated against such erring dental colleges and their details shall be posted on DCI website for information of all concerned:-

1.	Govt. Dental College, Srinagar
2.	Indira Gandhi Government Dental College, Jammu
3.	Harsaran Dass Dental College, Ghaziabad.

The aforesaid decision taken by the Executive Committee held on 12.08.2016 is placed before the Secretary, DCI for necessary directions to the server room to upload/post the above decision of the Executive Committee on DCI website and to delete earlier decision of the Executive Committee taken on 12.07.2016 and uploaded on DCI website on 22.07.2016.
