I am directed to invite your kind attention to this office Circular No.DE-MDS(Students)-2015/3976 dated 18.06.2015 thereby requesting all the dental colleges running Post Graduate Dental Course(s) to furnish the list of the students admitted in Post Graduate Dental Course(s) at their dental institutions for the academic session 2015-16, in the prescribed format duly verified by the Registrar of affiliating University, by 10<sup>th</sup> July 2015, positively to this Council by Speed Post / E-mail, and to enter / upload the data related to students admitted in Post Graduate Dental Course(s) for the academic session 2015-16 on DCI's website ([www.dciindia.org.in](http://www.dciindia.org.in)) by 10.07.2015.

In this connection, it is stated that since the seat matrix of Post Graduate Dental Course(s) for the academic session 2015-16 has now been updated on DCI Website, the last date for uploading the details of students admitted by the colleges in Post Graduate Dental Course(s) for the academic session 2015-16, which was earlier fixed as 10.07.2015, has now been extended for another 12 days w.e.f. 10<sup>th</sup> July, 2015.

In view of the above, the college authorities of all dental colleges running Post Graduate Dental Course(s) are hereby directed to upload the details of students, admitted in Post Graduate Dental Course(s) at their dental institutions for the academic session 2015-16, on DCI Website, using their already allotted login credentials, **within 12 days i.e. by 22.07.2015 (12:00 mid-night), positively**, and the online module for uploading the details of students shall be disabled at 12:00 mid-night on 22.07.2015, failing which it will be presumed that the college authorities have not admitted any student in Post Graduate Dental Course(s) at their college for the academic session 2015-16, and section 10B of the Dentists (Amendment) Act, 1993 shall be attracted.
