Sub: Uploading the details of students admitted in MDS Course(s)/PG Diploma Course(s) (Both under Government and/or Management Quota) at Dental Colleges during the academic session 2017-2018, on DCI Website.

Sir,

I am directed to refer to the subject cited above and to say that the last date upto which the students can be admitted/ joined against stray vacancies arising due to any reason in MDS Course(s)/PG Diploma Course(s) is **31st May of every year** as per Time Schedule for PG Courses as prescribed in "Dental Council of India (Establishment of New Dental Colleges, Opening of New of Higher Course of study or Training and Increase of Admission Capacity in Dental Colleges) (8th Amendment) Regulations, 2016".

2. Accordingly, the college authorities of all dental colleges are hereby directed to upload the details of students, admitted in MDS Course(s)/PG Diploma Course(s) at their dental institution for the academic session **2017-2018**, on DCI Website, using their already allotted login credentials, by **07.06.2017(12:00 midnight)**, positively, or in case you are not able to upload the same on DCI Website, you may send the list of above students with complete details, strictly in attached DCI prescribed format (Annexure-'A'), by hand/e-mail (secretary@dcindia.org) positively by **07.06.2017(12:00 midnight)**, mentioning the reason of not uploading such details on DCI Website, failing which it shall be presumed that the college authorities have not admitted any student in MDS Course(s)/PG Diploma Course(s) at their college for the academic session 2017-18 and if the college authorities claims any admission after 07.06.2017, then Section 10B of the Dentists (Amendment) Act, 1993 and Section 16A of the Dentists Act, 1948 shall be attracted.

3. The online module for uploading the details of students shall be disabled at 12:00 mid-night on 07.06.2017, and any hard copy or e-mail in this regard received after 12:00 mid-night on 07.06.2017 shall not be considered and no request for extension of time to upload the above details of students or any other excuse or reason of technical fault, etc. shall be considered, therefore, you are requested to ensure and make available all arrangements at your end to complete the above task, in time, so as to avoid any litigation and to enable this Council to take necessary action in a time bound manner.

4. You are also requested to upload the correct and complete details of subject students on DCI Website and no reason/excuse of typographical/clerical error shall be considered for uploading incomplete or wrong information/details of the students so admitted at your dental college. The Council may take necessary action against such erring dental colleges for uploading/furnishing wrong or incomplete information to DCI.

5. In case, any admission(s) is/are made in violation of Revised MDS Course Regulations, 2007 or the Time Schedule for the academic session 2017-18 or non compliance of above any direction for uploading the details of the students on DCI website or in violation of the provisions of the Dentists Act and Regulations made thereunder, the college authorities shall be liable to discharge such students failing which the provisions of the Section 10B of the Dentists (Amendment) Act, 1993 providing for non-recognition of dental qualification in respect of such students or / and the provisions of Section 16A for withdrawal of recognition for violation of conditions of admissions, as the case may be, would be initiated against such erring dental college(s).
