Sub: **Uploading of details of Dentists registered in Part "A" and Part "B" in State Dental Councils/Tribunals, on DCI Website to maintain Indian Dentists Register – Reg.**

Sir,

I am directed to say that the Government of India, Ministry of Health & Family Welfare, New Delhi during the discussion on various issues instructed the Dental Council of India to maintain online Indian Dentists Register under section 18(1) of the Dentists Act, 1948 and to make aware of such information to the General Public at large.

2. In this connection, I am directed to say that the Council has developed an online module on DCI website for all State Dental Councils / Tribunals, enabling them to upload the information/data of each and every dentist registered in Part A and Part B with all State Dental Councils / Tribunals.

3. As the DCI has already requested all State Dental Councils / Tribunals to upload the requisite details of dentists registered under Part A and Part B through online module on the website of Dental Council of India using already allotted secured login credential, so as to enable this Council to discharge its statutory function of maintenance of Indian Dentists Register under section 18 (1) of the Dentists Act, 1948, but the same has not been uploaded till date.

4. The above matter was considered by the Executive Committee of the DCI in its meeting held on 15.01.2016 at New Delhi and it was decided that all the State Dental Councils / Tribunals be requested to upload the requisite details of dentists registered at their State Dental Councils/Tribunals under Part A and Part B, using already allotted secured login credentials on the website OR develop an application/software for online registration of dentists at their State Dental Council / Tribunal and make the provision for link/synchronise their database with the database of online module developed by DCI on its website (www.dciindia.org.in), within a period of six months, so as to enable this Council to maintain online Indian Dentists Register.

5. In case, you have forgot/lost the password issued by DCI, you may reset the password by using the procedure of "Forgot Password" on login screen of DCI website.
