Sub: **Uploading of details of Dentists registered in Part "A" and Part "B" in State Dental Councils/Tribunals, on DCI Website to maintain Indian Dentists Register – Reg.**

Sir/Madam,

I am directed to inform you that as per section 18(1) of the Dentists Act, 1948, the Council shall maintain a register of dentists to be known as the Indian Dentists Register and consisting of the entries in all the State registers of Dentists, and as per section 18(2) of the Dentists Act, 1948, each State Dental Council shall supply to the Council twenty printed copies of the State register as soon as may be after the 1<sup>st</sup> day of April of each year, and each Registrar shall inform the Council without delay of all additions to and other amendments in the State Register.

It has been observed from past experience that most of the State Dental Councils are not sending the list of dentists of their state, in time and in uniform pattern which is not in accordance with the provisions of Dentists Act, 1948 resulting great difficulty in maintaining of Indian Dentists Register at the office of the Dental Council of India u/s 18(1) of the Dentists Act, 1948.

To overcome with the above situation, the Council has developed and launched DCI's new website ([www.dciindia.org.in](http://www.dciindia.org.in)) in which a separate module has been developed for all State Dental Councils / Tribunals, enabling them to enter/update the information/data of each and every dentist registered with your State Dental Council/Tribunal.

In view of the above, you are requested to upload requisite details of registered dentists under Part A and Part B, using the following allotted secured login credentials on the website, so as to enable this Council to maintain online Indian Dentists Register. The new website URL for this purpose is <http://www.dciindia.org.in> :-


